## DEER AND BEAR LICENSES

AN ACT to amend and re-enact Section 47-405, Wyoming Compiled Statutes, 1945, as amended and re-enacted by Section 2, Chapter 90, Session Laws of Wyoming, 1949, relating to resident deer and bear license, its purchase and rules and regulations governing same, and providing for a special permit for designated areas to kill two (2) deer and setting the fee therefor; and to amend and re-enact Section 47-421, Wyoming Compiled Statutes, 1945, relating to Non-resident deer permit, its purchase and rules and regulations governing same, and providing for a special permit for designated areas to kill two (2) deer and setting the fee therefor; and regulations governing same, and providing for a special permit for designated areas to kill two (2) deer and setting the fee therefor; and providing an effective date.

Be It Enacted by the Legislature of the State of Wyoming:

## Resident License—Purchase—Deer, Bear, Game Birds and Fish—Special Resident Deer License—Fee

Section 1. That Section 47-405, Wyoming Compiled Statutes, 1945, as amended and re-enacted by Section 2, Chapter 90, Session Laws of Wyoming, 1949, be amended and re-enacted to read as follows:

47-405. Any person who is qualified to receive a resident deer, bear, bird and fish license as defined in this Act, may purchase the same from the Wyoming Game and Fish Commission, or its authorized selling agents. Such license will entitle the holder thereof to hunt, pursue and kill deer, bear, and the game birds, and fish for the game fish within the State of Wyoming at such time, in such place, in such manner and in such amount as provided by law and the rules, orders or regulations of the Commission.

The Commission may issue a special resident deer license to be used only in areas designated by the Commission. Such special resident deer license shall be printed and used as above described except that it shall include two (2) deer tags, one of which is to be attached to each deer killed under this license as provided for in Section 47-524, Wyoming Compiled Statutes, 1945; said special deer license shall entitle the holder thereof to hunt, pursue and kill two (2) deer at such place and in such manner as provided by law and the rules, orders or regulations of the Commission. It is further provided that the license fee for this special resident deer permit shall be the sum of Six Dollars (\$6.00).

## Non-Resident Deer Permit-Special Non-Resident Deer License-Fee

Section 2. That Section 47-421, Wyoming Compiled Statutes, 1945, be amended and re-enacted to read as follows:

47-421. Any person who is qualified to receive a Non-resident Deer Permit, as defined in this Act, may purchase the same from the office of the Wyoming Game and Fish Commission, or from any duly authorized selling agent of the Commission. Such permit will entitle the holder thereof to hunt, pursue and kill one deer at such time, in such place and in such manner as provided by law and the rules, orders or regulations of the Commission.

The Commission may issue a special Non-resident deer license to be used only in areas designated by the Commission. Such special Non-resident deer license shall be printed and used as above described except that it shall include two (2) deer tags, one of which is to be attached to each deer killed under this license as provided for in Section 47-524, Wyoming Compiled Statutes, 1945; said special deer license shall entitle the holder thereof to hunt, pursue and kill two (2) deer at such place and in such manner as provided by law and the rules, orders or regulations of the Commission. It is further provided that the license fee for this special Non-resident deer permit shall be the sum of Twenty-five Dollars (\$25.00).
