8 Be It Enacted by the Legislature of the State of Wyoming:

9 Section 1. W.S. 23-2-101(b)(xxiii) and (xxiv) and
 10 23-2-104(b) through (d) are amended to read:

1 23-2-101. Fees; restrictions; nonresident applica-
2 tion fee; disposition of fees.

3 (b) The following licenses and tags may be purchased
4 for the fee indicated and subject to the limitations pro-
5 vided:

6 (xxiii) Resident archery license ~~(fee--each~~
7 ~~type-of-game)~~ 5.00

8 (xxiv) Nonresident archery license ~~(fee--each~~
9 ~~type-of-game)~~ 10.00

10 23-2-104. Archery licenses; special seasons; prohi-
11 bition against firearms and crossbows; equipment.

12 (b) The commission may establish special hunting
13 seasons for the taking of big game or trophy game animals
14 by bow and arrow ~~or--crossbow~~ in such areas as it may
15 establish by order.

16 (c) No person shall take BIG GAME OR TROPHY game
17 animals or game birds with bow and arrow ~~or--crossbow~~ with-
18 out first obtaining an archery license and the appropriate
19 hunting license except as otherwise provided.

20 (d) No person holding an archery license shall take

1 big game or trophy game animals during a special hunting
2 season while in possession of any type of firearm OR
3 CROSSBOW.

4 Section 2. This act is effective May 23, 1985.
