8	Be It Enacted by the Legislature of the State of Wyoming:

10	Section 1. W.S. 31-2-205 by creating a new subsection
11	(c) is amended to read:

13	31-2-205. Display of license plates.

15	(c) Notwithstanding subsection (a) of this section, a
16	special wildlife license plate may be displayed on the front
17	of the vehicle in lieu of the regular issued license plate.

1	The yearly dated renewal sticker shall be affixed to this
2	special plate displayed on the vehicle front plate position
3	in the same location as would be required on the usual
4	numbered plate. The department shall, after consultation
5	with the game and fish commission, prescribe the design of
6	the wildlife license plate. The department shall arrange
7	for the production of the special license plates which shall
8	be available for purchase upon application to the
9	department. A special application shall be issued by the
10	department upon payment of an application fee of thirty
11	dollars (\$30.00) in addition to the registration fees
12	prescribed by W.S. 31-3-101. The special application fee
13	under this subsection shall be used to cover the costs of
14	the special license plate and any administrative expenses
15	associated with application for the plate. Any excess
16	revenues shall be deposited in the state treasury and
17	credited to the game and fish fund created by W.S. 9-4-204.

19 Section 2. This act is effective immediately upon 20 completion of all acts necessary for a bill to become law as 21 provided by Article 4, Section 8 of the Wyoming 22 Constitution.
