AN ACT to amend and re-enact Section 27-805, Wyoming Compiled Statutes, 1945, as amended and re-enacted by Section 1, Chapter 104, Session Laws of Wyoming, 1949, fixing the compensation of County Commissioners and travel expenses and providing restrictions thereon.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. That Section 27-805, Wyoming Compiled Statutes, 1945, as amended and re-enacted by Laws 1949, Chapter 104, Section 1, be amended, and re-enacted as follows:

27-805. Each County Commissioner shall receive ONE THOUSAND DOLLARS (\$1,000.00) AND IN ADDITION THERETO (\*\*\*) TWELVE DOLLARS (\$12.00) per day for each day actually employed, but in no case shall the annual compensation in the respective Counties exceed the following amounts: In first class Counties, (\*\*\*) TWO THOUSAND, FIVE HUNDRED DOLLARS (\$2,500.00), in second class Counties, (\*\*\*) TWO THOUSAND DOLLARS (\$2,000.00), and in third class Counties, (\*\*\*) ONE THOUSAND, SIX HUNDRED DOLLARS (\$1,600.00). In addition thereto, each Commissioner shall be paid his actual expenses while away from his home on official County business (\*\*\*) and in the discharge of the duties of his office and provided further that in no event shall more than the following amounts be paid for expenses to any Commissioner in any calendar year: In first class Counties (\*\*\*) ONE THOUSAND, FIVE HUNDRED DOLLARS (\$1,500.00), in second class Counties (\*\*\*) ONE THOUSAND TWO HUNDRED FIFTY DOLLARS (\$1,250.00), and in third class Counties (\*\*\*) ONE THOUSAND DOLLARS (\$1,000.00). No Commissioners' salary or expense for any purpose shall be charged to any account other than the County Commissioner's account in the County Budget. No Commissioner shall be allowed any other salary from the County other than that herein stipulated.
