Source of revenue decrease:

A combination of sales and use taxes on dental/medical purchases.

Assumptions:

The use tax loss was based on the average per provider based on 5 audits (statistically not a valid sample). The sales tax is based on 3 years of revenue for SIC 5047 and 8021. We cannot know how much of their supplies would fall under the exemption so the numbers given are definitely inflated, but we cannot tell by how much.
