LETTER ORDER
(Issued June 8, 2022)

Dear Ms. White:

On May 19, 2022, Cheyenne Light, Fuel and Power Company d/b/a Black Hills Energy (Cheyenne Light) filed with the Wyoming Public Service Commission (Commission) a *Petition for Confidential Treatment of Response to OCA Data Request 3.2 (Petition)* requesting confidential treatment for a portion of the response to the Office of Consumer Advocate's data request 3.2 as it contains confidential landowner data, and if disclosed, could harm the landowner and Cheyenne Light.

Chapter 2, Section 30 of the Commission's Rules provides, in part:

(a) Upon petition, and for good cause shown, the Commission shall deem confidential any information filed with the Commission or in the custody of the Commission or staff which is shown to be of the nature described in Wyoming Statute §16-4-203(a), (b), (d) or (g). All information for which confidential

treatment is requested shall be treated as confidential until the Commission rules whether, and to what extent, the information shall be given confidential treatment.

Cheyenne Light's *Petition* came before the Commission at its Open Meeting on May 31, 2022. Commission Counsel recommended granting the *Petition*.

The Commission finds that Cheyenne Light's *Petition* is generally consistent with the provisions of Chapter 2, Section 30 of the Commission's Rules and the information described therein is of the character subject to protection under Wyo. Stat. § 16-4-203(d)(v) and this Rule. The Commission concludes that Cheyenne Light has shown good cause for its request.

IT IS THEREFORE ORDERED:

1. Pursuant to Open Meeting action taken May 31, 2022, Cheyenne Light, Fuel and Power Company d/b/a Black Hills Energy's *Petition for Confidential Treatment of Response to OCA Date Request 3.2* is granted.
2. This *Letter Order* is effective immediately.


