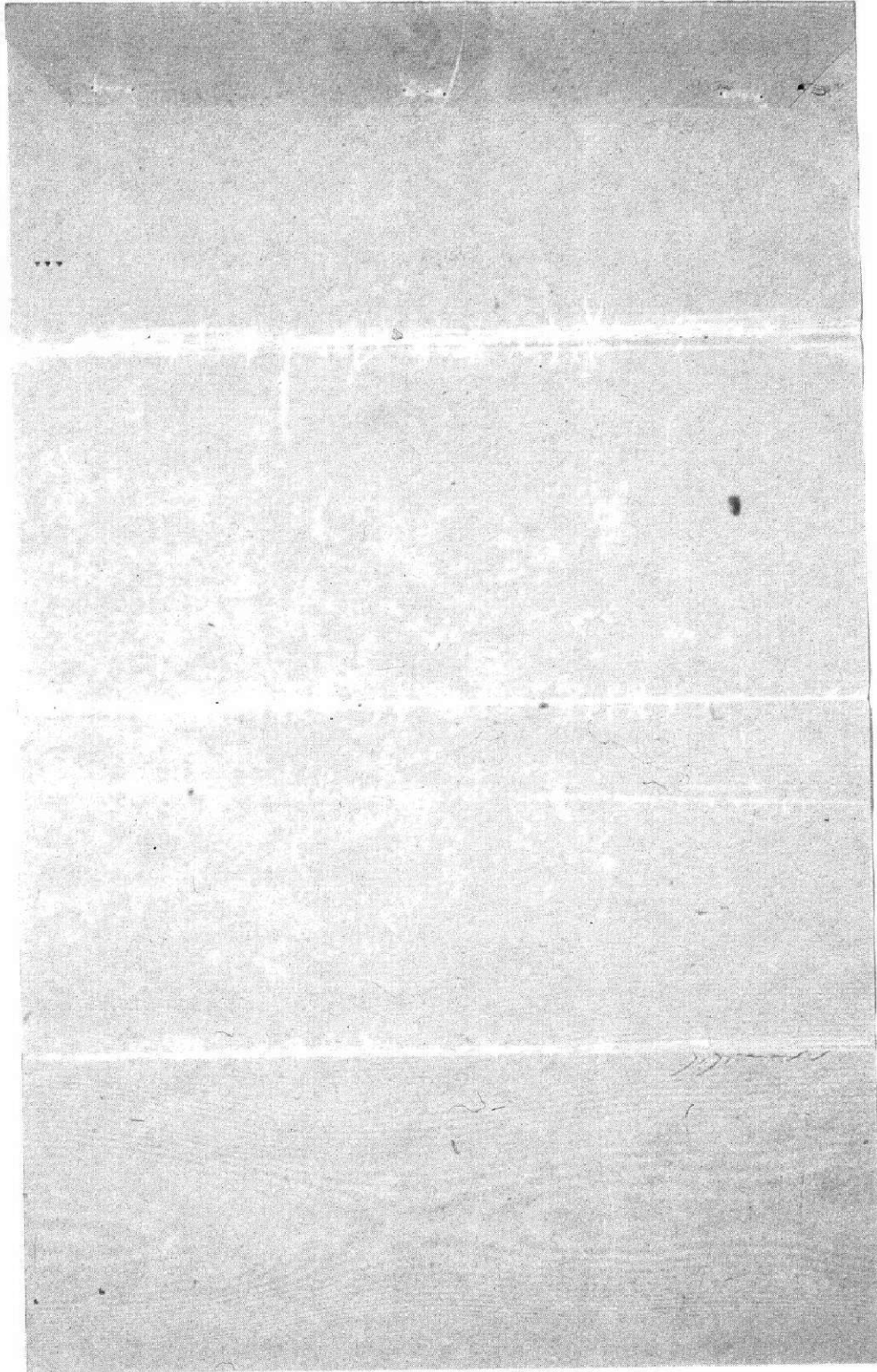

AN ACT to amend and re-enact Section 13, Chapter 7, Session Laws of Wyoming, Special Session, 1948, providing that the provisions of Chapter 7 shall not apply to certain hospitals and directing the submission of a code of hospital standards to the Thirty-first Legislature.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. That Section 13, Chapter 7, Session Laws of Wyoming, Special Session, 1948, be amended and re-enacted to read as follows:

Section 13. * * * NO PROVISION OF THIS ACT, OR ANY RULE OR REGULATION PROMULGATED BY THE STATE DEPARTMENT OF PUBLIC HEALTH UNDER THE AUTHORITY OF THIS ACT SHALL BE APPLICABLE TO ANY HOSPITAL OF THE STATE NOT AVAILING ITSELF OF THE AID PROVISIONS OF THIS ACT. THE STATE BOARD OF HEALTH IS HEREBY DIRECTED TO SUBMIT A CODE OF HOSPITAL STANDARDS FOR ALL HOSPITALS OF THE STATE TO THE THIRTY-FIRST LEGISLATURE OF THE STATE OF WYOMING FOR ITS CONSIDERATION AND APPROVAL.
