

5 Be It Enacted by the Legislature of the State of Wyoming:

6 Section 1. W.S. 21-18-303(b) is amended to read:

7 21-18-303. District board generally; powers; board
8 approved additional mill levy.

9 (b) In addition to the levy imposed under W.S.
10 21-18-304(a)(vii) and any levy imposed under W.S.

1 21-18-311(f) the community college district board may
2 approve up to one (1) additional mill levy on the assessed
3 value of the district for a period not to exceed two (2)
4 years for the regular support and operation of the col-
5 lege. A determination by the board shall be made at a
6 regular or special meeting following a public hearing
7 announced by the board. Notice of intent to levy all or a
8 portion of the additional one (1) mill shall be published
9 in a newspaper of general circulation within the district
10 at least thirty (30) days before the hearing date. Upon
11 approval, the board shall report the additional levy to
12 the board of county commissioners of each county within
13 the district in the same manner the necessary levy under
14 W.S. 21-18-304(a)(vii) is reported. Any tax imposed under
15 this subsection may be renewed by the board for an addi-
16 tional two (2) years YEAR PERIODS subject to public hear-
17 ing requirements specified under this section and shall be
18 levied, collected and distributed separate from the tax
19 imposed under W.S. 21-18-304(a)(vii) and any additional
20 levy imposed under W.S. 21-18-311(f). Revenues collected
21 under this subsection shall not be used in establishing
22 the biennial budget authority of the college under W.S.
23 21-18-205(b).

1 Section 2. This act is effective immediately upon
2 completion of all acts necessary for a bill to become law
3 as provided by Article 4, Section 8 of the Wyoming Consti-
4 tution.
