LETTER ORDER

(Issued July 17, 2019)

Dear Ms. Douglas:

This matter is before the Wyoming Public Service Commission (Commission) upon United Telephone Company of the West d/b/a CenturyLink (CenturyLink or the Company) tariff filing to revise its General Exchange Price Schedule Section 6 in the above-docketed matter.

On June 12, 2019, CenturyLink filed its Application to revise its General Exchange Price Schedule 6 regarding WUSF and FUSF credits to be applied to customer bills pursuant to the Commission's *Order Establishing the Wyoming Universal Service Fund (WUSF) Assessment Level on a Final Basis (Final Order)*, issued June 26, 2019 for the July 2019 and June 2020 Fiscal Year in Docket No. 90072-45-XO-19 (Record No. 15201). The Company's updated changes are on the Company's General Exchange Price Schedule, Section 6, 4<sup>th</sup> Revision Sheet 3 Price Schedule, and are showing in Table 1 below.

There is no impact to Wyoming customers, because the price schedule changes reflect adjustments in federal and state subsidy amounts credited, which credits do not affect the net amount charged to customers.

CenturyLink's tariff filing came before the Commission pursuant to due notice at its Open Meeting on July 15, 2019. Commission Staff recommended approving the Application.

The Commission finds that CenturyLink's tariff changes are in compliance with the Commission's *Final Order*. Accordingly, the Commission concludes CenturyLink has shown good cause for its request and further concludes the Application should be approved.

IT IS THEREFORE ORDERED:

1. Pursuant to Open Meeting action taken on July 15, 2019, United Telephone Company of the West d/b/a CenturyLink of the West's tariff filing to revise its General Exchange Price Schedule Price Schedule 6 regarding WUSF and FUSF credits to be applied to customer bills, effective July 1, 2019, is approved.

2. This *Letter Order* is effective immediately.
