> LETTER ORDER (Issued June 26, 2015)

Dear Mr. Roesel:

This matter is before the Wyoming Public Service Commission (Commission) upon Neutral Tandem-Wyoming, LLC (Neutral Tandem) tariff filing to reduce its access tariffs in compliance with FCC 11-161 in the above-docketed matter.

On June 17, 2015, Neutral Tandem filed tariff changes to reduce its access tariffs filed pursuant to the Federal Communications Commission's November 18, 2011, *Report and Order and Further Notice of Proposed Rulemaking* in WC Docket Nos. 10-90, etc. (FCC 11-161) and in accordance with the Commission's Order Establishing Procedures for Filings Related to Telecommunications Companies' Compliance with FCC Report and Order 11-161 and its Requirement to File Revised Access Tariffs in 2015 (Procedural Order) issued on June 5, 2015, in Docket No. 90000-123-XO-15.

Neutral Tandem's tariff filing came before the Commission pursuant to due notice at its open meeting on June 23, 2015. Commission Staff recommended approving the tariffs.

The Commission finds that Neutral Tandem's tariff changes result in a reduction of its access rates and is in compliance with FCC 11-161 and the Commission's *Procedural Order*. The Commission concludes Neutral Tandem has shown good cause for its request and further concludes the tariffs should be approved.

## IT IS THEREFORE ORDERED:

1. Pursuant to open meeting action taken on June 23, 2015, Neutral Tandem-Wyoming, LLC's tariff filing to reduce its Access Tariffs in compliance with FCC 11-161, effective July 1, 2015, is approved.

2. This *Letter Order* is effective immediately.
