Re: IN THE MATTER OF UNION TELEPHONE COMPANY'S PETITION FOR CONFIDENTIAL TREATMENT OF ITS 2021 ANNUAL REPORT– DOCKET NO. 62006-33-TG-22 (RECORD NO. 17050)

LETTER ORDER

(Issued July 19, 2022)

This matter is before the Wyoming Public Service Commission (Commission) upon Union Telephone Company's (Union or Company) *Petition for Confidential Treatment (Petition)*. The Commission, having reviewed the *Petition*, its files regarding Union, applicable Wyoming telecommunications law, and otherwise being fully advised in the premises, FINDS and CONCLUDES:

1. Union is a telecommunications company as defined by Wyo. Stat. § 37-15-103(a)(xi), subject to the Commission's jurisdiction pursuant to Wyo. Stat. § 37-15-401.
2. On April 29, 2022, Union filed its *Petition* requesting confidential treatment of its 2021 Annual Report.
3. Union's *Petition* came before the Commission pursuant to due notice at its Open Meeting on July 12, 2022. Commission Staff recommended the Commission grant the *Petition*.
4. Based on the *Petition*, the representations by Union, and the recommendations of Commission Staff, the Commission finds and concludes that the *Petition* complies with

Commission Rule Chapter 2, Section 30 and for good cause shown should be granted. The granting of confidential treatment is limited to the 2021 Annual Report filing.

IT IS THEREFORE ORDERED:

1. Pursuant to Open Meeting action taken on July 12, 2022, Union Telephone Company's *Petition for Confidential Treatment*, is granted with respect to the 2021 Annual Report.
2. This *Order* is effective immediately.
