

5 Be It Enacted by the Legislature of the State of Wyoming:

6 Section 1. W.S. 12-4-102(a)(v) is amended to read:

7 12-4-102. Application for licenses and permits; con-
8 tents of application, etc.; signature and verification.

9 (a) Any person desiring a license or permit author-

1 ized by this title shall apply to the appropriate licens-
2 ing authority. The application shall be made under oath
3 upon a form to be prepared by the attorney general and
4 furnished to the licensing authority. The application
5 shall be filed in the office of the clerk of the appropri-
6 ate licensing authority and shall contain the following
7 provisions:

8 (v) A statement indicating the financial
9 condition and financial stability of ~~the~~ A NEW applicant;

10 Section 2. This act is effective May 20, 1981.
