11 TWO DOLLARS (\$2.00) the temporary license permit obtained
12 from the authorized dealer may be renewed once for an
13 additional FIFTEEN (15) day period.

1 Section 2. This act is effective ninety (90) days
2 after adjournment of the session of the legislature at
3 which it was enacted.
