W.S. § 35-1-404(a)(v) requires the Wyoming Department of Health, Vital Statistics Services to provide a report to the Governor on the administration of the Vital Statistics Services. The relevant statute states:

(i) Make, promulgate and enforce all necessary rules and regulations for carrying out the purpose of this act; (ii) Receive, index and statistically compile the returns of births, deaths, stillbirths, marriages and divorces from the entire state; (iii) Prescribe and distribute such forms as are required by this act and the rules and regulations issued hereunder; (iv) Direct, supervise and control the activities of local registrars and the activities of other local officials related to the operation of the vital records system and provide them with necessary postage; (v) Submit to the governor an annual report of the administration of this act; (vi) Keep a correct account of all fees received and turn the same over to the state treasurer as provided by law; (vii) Delegate such functions and duties vested in him to officers and employees of the office of vital records services and to the local registrars as he deems necessary or expedient; (viii) Investigate all of the cases of irregularity or violation of this act and any regulations.

Section 1. Executive Summary

W.S. § 35-01-403 and W.S. § 35-01-404(a)(v) direct the Wyoming Department of Health (WDH) State Registrar to install, operate, and maintain a system for all vital records and to submit to the Governor an annual report of its administration.

In calendar year 2014, the Vital Statistics Services (VSS) office recorded the following number of events:

- 7,693 Births;
- 4,633 Deaths;
- 4,476 Marriages; and
- 2,443 Divorces.

In addition, VSS answered 29,283 requests for services/certificates, and issued over 62,811 certified copies of Wyoming vital records to residents and customers. These records included:

- 28,170 Birth Certificates;
- 33,134 Death Certificates;
- 1,191 Marriage Certificates;
- 312 Divorce Certificates; and
- 4 Stillbirth Certificates.

Section 2. Specific Requirements of Statute

W.S. § 35-1-404(a)(v) requires the department of health to submit an annual report to the Governor on its activities. The relevant statute specifically states:

35-1-404. Duties of state registrar.

(a) The state registrar shall:

- (i) Make, promulgate and enforce all necessary rules and regulations for carrying out the purpose of this act;
- (ii) Receive, index and statistically compile the returns of births, deaths, stillbirths, marriages and divorces from the entire state;
- (iii) Prescribe and distribute such forms as are required by this act and the rules and regulations issued hereunder;
- (iv) Direct, supervise and control the activities of local registrars and the activities of other local officials related to the operation of the vital records system and provide them with necessary postage;

- (v) Submit to the governor an annual report of the administration of this act;
- (vi) Keep a correct account of all fees received and turn the same over to the state treasurer as provided by law;
- (vii) Delegate such functions and duties vested in him to officers and employees of the office of vital records services and to the local registrars as he deems necessary or expedient;
- (viii) Investigate all of the cases of irregularity or violation of this act and any regulations.

Section 3. Response to Specific Requirements of Statute

W.S. § 35-01-403 and W.S. § 35-01-404(a)(v) direct the Wyoming Department of Health (WDH) State Registrar to install, operate, and maintain a system for all vital records and to submit to the Governor an annual report of its administration.

Administration

The collection of vital event data (birth, death, marriage and divorce) is essential for two purposes:

- Certified records allow Wyoming residents to prove identity, obtain a driver's license (Real ID Act), gain employment, access survivor's benefits or attend school.
- Data informs public policy and program planning.

The Vital Statistics Services (VSS) office examines residence data for births and deaths. This residence data accounts for all Wyoming residents including those residents that give birth outside of the state.

Exchange of resident event data, which occurs outside Wyoming, is transferred through federal applications/systems: the Electronic Verification of Vital Events (EVVE) and the State Territorial Exchange of Vital Events (STEVE). Data for marriages and divorces reference only those events that occurred inside the state.

VSS is primarily administered with state general funds and returns funds back to both the general and children's trust funds (W.S. § 14-8-106) through the sale of certified copies of vital events.

In calendar year 2014, VSS recorded the following number of events:

- 7,693 Births;
- 4,633 Deaths;
- 4,476 Marriages; and
- 2,443 Divorces.

In addition, the VSS staff, consisting of ten state employees, answered 29,283 requests for services/certificates, and issued over 62,811 certified copies of Wyoming vital records to residents and customers. These records included:

- 28,170 Birth Certificates;
- 33,134 Death Certificates;
- 1,191 Marriage Certificates;
- 312 Divorce Certificates; and
- 4 Stillbirth Certificates.

The VSS office maintains over one million recorded events in a variety of media types, such as electronic, paper, microfilm and microfiche, and stores these records in four (4) geographically dispersed locations.

The VSS electronic system has multiple components and contains about one-half of Wyoming's vital records. Developed "in house" in 2009, it provides users a system to input and access vital events data throughout the state. The physical and virtual system(s) require secure access in addition to a repository, hosting, code development, maintenance, updates, replication, backup and large amounts of storage capacity for the application and the archived data. The electronic registration application has over 1,600 users throughout Wyoming and five (5) adjoining states. Users consist of county clerks who administer marriages; clerks of district court who complete divorce filings; funeral homes and medical personnel who file and complete local death certificates; and hospital health information managers, midwives, and physicians who file and certify births. The application requires 24-hour accessibility and reliability for all users to adhere to statutory filing requirements.

The agency is moving toward consolidating all media type into one; i.e., electronic (digital) media that is secure, accessible, and can provide long-term storage. The VSS expects to spend an estimated \$500,000 on this effort within the next two years.

Resident Births

A total of 7,693 births were reported to Wyoming residents during the calendar year 2014. Of these births, 824 occurred outside of the state to Wyoming residents. For the last five years, Wyoming's birth rate has remained at approximately 13 births per 1,000 residents, slightly above the national average - as shown in Table 1, on the following page.

The average filing time for births is seven days, which is less than the statutory ten days, but the average number of days from birth to recording for the event is 14 days. The agency goal for recording births is ten days. The additional four days for recording is tied to the requirements for ascertaining paternity and facility (hospital or clinic) file rejection.

There were 2,412 births that required some form of paternity input. These filings require signatures accepting responsibility for parentage and in some instances, denying paternity. These data are shared with Wyoming Department of Family Services and the forms comply with state law. Currently, these forms are mailed directly to the VSS office that adds to the number of days to record the birth event. One full-time state employee, who communicates on a daily basis with both customers and stakeholders, manages the VSS Birth Registration Unit.

Facility file rejection rates also contribute to the increased time for recording births. In 2014, the average monthly rejection rate was 69.5 per month. Rejections are based on a number of filing errors entered by a facility. In the last eight months, the rejection rate has decreased to 55 per month. This decrease can be attributed to better communication with facilities and an increase in educational material distributed to these groups by the VSS staff. As this rejection rate continues to decline, we expect to see a decrease in the number of days for recording, drawing closer to the ten-day target.

Wyoming continues to contribute birth data and enumeration at birth via EVVE and STEVE to the Center for Disease Control (CDC) and Social Security Administration (SSA), respectively. For the calendar year 2014, these agencies rate Wyoming VSS as "green," or meeting contract expectation for timeliness of reporting and data accuracy.

Births to Teen Mothers

In 2014, 548 resident teens added to the population in Wyoming. The trend has stabilized following a significant decrease over the last five years, shown in Table 2, on the next page. Wyoming continues to experience a higher teen birth rate than the national average.

Deaths

4,633 Wyoming residents died during calendar year 2014. Wyoming's death rate is below the national rate and has remained relatively stable over the last five years, as shown in Table 3, below. VSS provides death data to both state and federal partners and is the lead provider for cause of death data.

Accurate and timely death data is critical for Wyoming residents; a new On-line Verification System (OVS) for SSA notification was implemented this calendar year with the goal of increasing data accuracy and decreasing both the filing and recording times for death events.

This application, coupled to the VSS Electronic Death Registration System (EDRS) has increased the accuracy of the system data and is decreasing the time for death registration. The OVS allows immediate verification by the SSA to a pending fact of death because the decedent's record is "flagged" at the same time the funeral home enters the demographics for the individual. This activity removes the requirement for the notification of death (Form SSA-721) to be mailed alerting the SSA of a participant/account holder death. The objective for OVS is to eliminate SSA overpayments, reimbursements and repayments due to late notification and to decrease the time required to file a death certificate.

Wyoming's average filing for fact of death is two days in the EDRS. This is within the statutory requirement of three days. The VSS office requires all certificates to be filed electronically, with the goal of reducing the amount of paper being used to record

deaths and to eliminate errors in transcription and lost certificates. By eliminating these variables and allowing physicians and local registrars the opportunity to review and sign certificates online, the office will decrease the average recording fact of death timeline from 14 days to ten days for all natural deaths. Those events requiring additional reports or investigations will be targeted at 30 days for pathology and 45 days for those requiring autopsy and coroner investigation.

Marriages

In 2014, there were 4,476 new marriages in Wyoming. This trend has been consistent over the last five years.

Beginning in October 2014, VSS implemented an update to applications and forms used by county clerks to issues licenses in accordance with federal court rulings. This activity united the relationship and clarified processes VSS shares with the county clerks throughout the state.

The VSS staff participated in three clerk association meetings to gather information, test and implement the necessary changes to the marriage system to ensure Wyoming met the federal requirements for accepting and processing same-sex marriages. Modifications to the VSS system continue today to support the clerks as they migrate and upgrade to different online systems for accounting and issuing licenses.

Twelve counties use the state VSS system; the others use contract off the shelf systems; e.g., Tylertech or a hybrid system developed within the county.

Divorces

In 2014, there were 2,443 divorces in Wyoming. The trend is fairly consistent, but has shown a slight decrease from 2010, as seen in Table 5, below.

In concert with the changes for marriage vital events, VSS had been filing court orders petitioning divorce, but following the October 2014 ruling, changed the language for the records to address the courts' petitions, using the terms, "petitioner" and "respondent" instead of "husband" and "wife."

These changes required thoughtful reasoning while addressing the links and functions of the tables already implemented in the system's database. We continue to change and update various aspects of the system to ensure each record is accurate and available for customers, while maintaining requirements within both state and federal law.

Currently, all county clerks of district court use the state VSS for filing divorces.

Definitions and Technical Calculations

Residence Data - Data compiled on the basis of the place of residence of the decedent (deaths) or the place of residence of the child's mother (births). For example, a child who is born in Denver, Colorado (Denver County) but the mother claims residence in Casper, Wyoming (Natrona County) would be included in the resident count for Natrona County. Wyoming receives birth and death certificates from other states for Wyoming residents that were born or died in the other state. Temporary residence such as a visit, business trip, or vacation is not considered the usual place of residence.

Residence data is mostly used in the birth tables because Wyoming does not have a tertiary (level 3) care unit for those babies who need extra care. Consequently, many high risk births occur out of state. Resident data is important to programs such as a statewide breastfeeding effort that targets residents.

Occurrence Data - Data compiled on the basis of where the event actually occurred, regardless of the person's place of residence. For example, a person died in Laramie, Wyoming (Albany County) but claimed residence in Goshen, Wyoming (Platte County) would be included in the occurrence count for Albany County. This data would also include a non-resident of Wyoming who died in Wyoming. For example, a resident from Denver, Colorado (Denver County) that died in Casper, Wyoming (Natrona County) would be included in the occurrence count for Natrona, County. This individual would not be included in any resident counts.

Occurrence data can be important to show the patterns of intra-state and inter-state mobility for health care needs. For example, a major birthing hospital in a large city near the state's border will attract mothers from other areas of the state as well as from the neighboring state. In Wyoming, several counties including Big Horn, Crook, Niobrara, and Sublette do not have birthing facilities within their borders; consequently, mothers travel to other areas of Wyoming or outside of Wyoming to give birth. This is also true for those individuals that die. They may seek care at a major hospital outside of the state.

Live Birth - A birth that shows any sign of life after delivery.

Low Birth Weight Baby - A baby born weighing less than 2500 grams or 5 pounds 8 ounces.

Preterm Baby - A baby born before 37 weeks gestation.

Definitions and Technical Calculations (Page 2 of 4)

Adequacy of Prenatal Care Utilization Index (APNCU) - A measure of prenatal care utilization that was developed by Kotelchuck and examines two dimensions. The first dimension examines the timing of initiation and the second dimension looks at the ratio of actual number of visits to expected number of visits. American College of Obstetricians and Gynecologists (ACOG) recommends 14 visits. Rates are classified as "Adequate Plus, Adequate, Intermediate, or Inadequate."

- **Adequate Plus** - Defined as prenatal care starting in the fourth month and 110% or more of recommended visits.
- **Adequate** - Defined as prenatal care starting in the fourth month and 80-109% of recommended visits.
- **Intermediate** - Defined as prenatal care starting in the fourth month and 50-79% of recommended visits.
- **Inadequate** - Defined as prenatal care starting in the fourth month and less than 50% of recommended visits.

Maternal Death - A death of a mother caused by complications of pregnancy, childbirth, or the puerperium period.

Infant Death - A death of a live born infant under one year of age.

- **Neonatal Death** - A death of a live born infant under 28 days of age.
- **Post-Neonatal Death** - A death of a live born infant between 28 and 364 days of age.

Fetal (Stillborn) Death - Death taking place after 20 weeks gestation and before birth.

Tertiary care — Specialized consultative health care, in a facility that has personnel and facilities for advanced medical investigation and treatment.

Crude Birth Rate – Number of live births per 1,000 total population.

$$\left(\frac{\text{Live Births}}{\text{Total Population}} \right) * 1000$$

Fertility Birth Rate – Number of live births per 1,000 women 15-44 years of age.

$$\left(\frac{\text{Live Births}}{\text{Females Ages 15-44}} \right) * 1000$$

Crude Death Rate – Number of deaths per 100,000 population.

$$\left(\frac{\text{Deaths}}{\text{Total Population}} \right) * 100,000$$

Infant Death Rate – Number of infants under one year of age that died per 1,000 live births.

$$\left(\frac{\text{Infant Deaths}}{\text{Live Births}} \right) * 1000$$

Age-Adjusted Death Rate – Rates are used to statistically allow comparison between different size groups. It is computed by applying age-specific death rates to a standard population. Age-adjusted rates should not be compared to crude rates.

Marriage Rate – Number of marriages per 1,000 population.

$$\left(\frac{\text{Marriages}}{\text{Total Population}} \right) * 1000$$

Divorce Rate – Number of divorces per 1,000 population.

$$\left(\frac{\text{Divorces}}{\text{Total Population}} \right) * 1000$$
