LETTER ORDER

(Issued July 3, 2019)

Dear Mr. Hendricks:

This matter is before the Wyoming Public Service Commission (Commission) upon RT Communications, Inc.'s (RT) tariff filing to revise its access tariffs in compliance with FCC Docket 10-90, 11-161, and PSC Docket No. 90000-141-XO-19 in the above-docketed matter.

On June 7, 2019, RT filed tariff changes to revise its access tariffs filed pursuant to the Federal Communications Commission's (FCC) November 18, 2011, *Report and Order and Further Notice of Proposed Rulemaking* in WC Docket Nos. 10-90, etc., (FCC 11-161) and in accordance with the Commission's *Order Establishing Procedures for Filings Related to Telecommunications Companies' Compliance with FCC Report and Order 11-161 and its Requirement to File Revised Access Tariffs in 2019 (Procedural Order)* issued on May 7, 2019, in Docket No. 90000-141-XO-19 (Record No. 15246).

RT's tariff filing came before the Commission pursuant to due notice at its Open Meeting on June 28, 2019. Commission Staff recommended approving the tariff changes.

The Commission finds that RT's revised tariffs are in compliance with FCC Docket 10-90, 11-161, and the Commission's *Procedural Order*. The Commission concludes RT has shown good cause for its request and further concludes the revised tariffs should be approved.

IT IS THEREFORE ORDERED:

1. Pursuant to Open Meeting action taken on June 28, 2019, RT Communications, Inc.'s tariff filing to revise its Access Tariffs in compliance with FCC Docket 10-90, 11-161, and PSC Docket No. 90000-141-XO-19, effective July 1, 2019, is approved.

2. This *Letter Order* is effective immediately.
