5 Be It Enacted by the Legislature of the State of Wyoming:

6 Section 1. W.S. 26.1-330.1 is created to read:

7 26.1-330.1. Insurance commissioner; uniform health
8 insurance claim form. The commissioner shall prescribe a
9 uniform health insurance claim form which shall be used by
10 all insurers transacting health insurance in this state
11 and by all hospitals and governmental agencies of this
12 state that require health insurance claim forms for their
13 records.

1 Section 2. This act is effective immediately upon
2 passage.
