A BILL for AN ACT to provide that counties, municipalities. schools, hospital or other special districts, or any two or more of them within a single county, may jointly establish and operate certain facilities, and to jointly secure and operate equipment for same; providing limitations on expenditures.

Lines 2 and 3 of the Title, strike the words "towns or cities" and

Line 11, page 1, strike the word "and"

Lines 13 and 14, page 1, strike the words "towns or cities and insert the words "municipalities, school, hospital or other special districts"

Line 16, page 1, strike the words "towns or"

Line 1, Page 2, strike the word "cities" and insert the words "municipalities, school, hospital or other special districts"

Strike Section 3 and insert a new Section 3 as follows: "Section 3. The costs of such joint operations and joint use of machinery and facilities shall be shared among the county and the contracting municipality, school, hospital or other special district, as shall be determined by the board of county commissioners of such county jointly with the governing body of the municipality, school, hospital or other special district"

Lines 12 and 13, strike the words "town or city" and insert the words "municipality, school, hospital or other special district"

Line 15, page 2, strike the words "county, town or city." and insert the words "such county, municipality, school, hospital or other special district"

Page 1, line 15, after "county" insert "municipality, school, hospital or other special district, or any two or more of them within a single county,". Page 1, line 15, delete

last 5 words. Page 2, line 1, delete "municipalities, school, hospital or other special districts" and "within its boundaries". Page 2, Section 3, after second "the" delete balance of Section and insert "contracting parties as shall be determined by their governing bodies". Page 2, line 12, delete "either the" and insert "any". Page 2, line 12, delete "town or" and insert "party". Page 2, line 13, delete first 5 words. Page 2, line 14, delete "State". Page 2, line 15, delete all but first two words and insert in lieu thereof "it". Except in title wherever "municipalities" appears, change to "municipality". Except in title wherever "districts" appears, change to "district".
