adopt rules for audits and may examine the accounts of any entity receiving state funds under this act. The legislative service office may audit the accounts of any entity. These accounts shall be maintained in a manner to guarantee confidentiality of the patient's identity. The state auditor and treasurer shall not disburse any state money to any entity refusing access to its accounts and records for the purposes of this section.

**Section 2.** W.S. 28-5-101(c) is repealed.

**Section 3.** This act is effective July 1, 2016.

# Chapter 52

#### LIVESTOCK DEALERS

Original House Bill No. 36

AN ACT relating to livestock dealers; eliminating the repeal date for provisions related to the registration of livestock dealers as specified; and providing for an effective date.

Be It Enacted by the Legislature of the State of Wyoming:

**Section 1.** W.S. 11-22-101(a)(iv)(B) and (v) is amended to read:

# 11-22-101. Definitions; exceptions to provisions.

- (a) As used in this act:
  - (iv) "Livestock dealer" means:
- (B) Any person who engages in the regular business of buying or selling livestock in commerce on a commission basis as set forth in rules by the Wyoming livestock board. This paragraph is repealed effective June 30, 2016.
- (v) "Livestock dealer" does not include any person who buys or sells livestock as part of his own bona fide breeding, feeding, showing, dairy, meat or wool production operation; any person who takes a security interest, including liquidation of that interest, in livestock in the ordinary course of his business; or any person who buys occasionally but not as a part of his regular business as set forth in rules promulgated by the Wyoming livestock board; This paragraph is repealed effective June 30, 2016;
  - **Section 2.** W.S. 11-22-118(e) is repealed.
- **Section 3.** This act is effective immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.

#### **CATERING PERMITS**

Original House Bill No. 84

AN ACT relating to local licenses; increasing the number of catering permits a person or organization may receive in a year; and providing for an effective date.

Be It Enacted by the Legislature of the State of Wyoming:

**Section 1.** W.S. 12-4-502(c) is amended to read:

# 12-4-502. Twenty-four hour malt beverage permit and catering permit; restrictions; application procedure; fees.

(c) The permits authorized by this section shall be issued for one (1) twenty-four (24) hour period, subject to the schedule of operating hours provided by W.S. 12-5-101. No person or organization shall receive more than a total of twelve (12) malt beverage and twenty-four (24) thirty-six (36) catering permits for sales at the same premises in any one (1) year, except that this limitation shall not be applicable to malt beverage permits issued for sales at any fair, rodeo, pari-mutuel event or other similar public event conducted by a public entity upon public premises, or to catering permits for events at the facilities of the University of Wyoming in Laramie, including the Marian H. Rochelle Gateway Center.

**Section 2.** This act is effective immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.
