8 *Be It Enacted by the Legislature of the State of Wyoming:*

10 **Section 1.**

11

12 (a) It is the intent of the Wyoming legislature to  
13 return control of the grizzly bear management program to the  
14 United States fish and wildlife service on January 1, 2001,  
15 if the grizzly bear has not been delisted under the  
16 Endangered Species Act by that date. If, at a later date,  
17 the grizzly bear is delisted under the Endangered Species

1 Act, it is the intent of the Wyoming legislature that the  
2 Wyoming game and fish department shall at that time include  
3 the grizzly bear in its state management plan and  
4 conservation strategy.

6 (b) No later than October 31, 1999, the Wyoming game  
7 and fish department shall present to the joint travel,  
8 recreation, wildlife and cultural resources interim  
9 committee a plan that will return all elements of the  
10 grizzly bear management program to the United States fish  
11 and wildlife service.

13 **Section 2.** This act is effective July 1, 1999.
