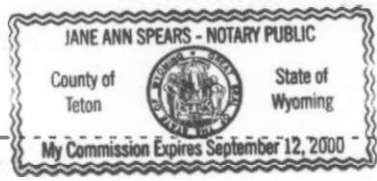

Following is an amended Trademark Description:

Our mark consists of a circle containing a depiction of two fishermen, one at the oars, in a drift boat floating down a river channel with the Teton Range in the background. The range is pictured head on and due east of the Grand Teton. The fisherman's fly line extends to a fly silhouette which is just outside and above left-center of the circular enclosure. The words Westbank Anglers appear outside the circular enclosure.

The trademark described above has been in use since June 1986 for the purpose of identifying Westbank Anglers products, merchandise and services.

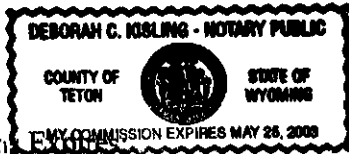

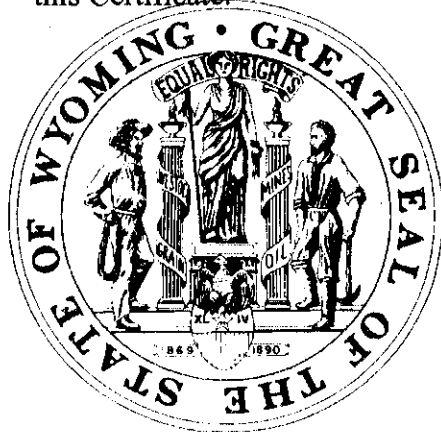
