AN ACT to amend and re-enact Section 122-207, Wyoming Revised Statutes, 1931, as amended and re-enacted by Section 8, Chapter 103, Session Laws of Wyoming, 1933; Section 109-1214, Wyoming Revised Statutes, 1931, as amended and re-enacted by Section 14, Chapter 103, Session Laws of Wyoming, 1933, as amended and re-enacted by Section 7, Chapter 149, Session Laws of 1937; Section 57-102, Wyoming Revised Statutes, 1931; Section 57-105, Wyoming Revised Statutes, 1931, as amended and re-enacted by Section 13, Chapter 103, Session Laws of Wyoming, 1933; Section 1 of Chapter 93, Session Laws of Wyoming, 1933; Section 5 of Chapter 85, Session Laws of Wyoming, 1933 as amended and re-enacted by Section 1 of Chapter 75, Session Laws of Wyoming, 1937 relating to the salaries of certain state officers and employees.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. That Section 122-207, Wyoming Revised Statutes, 1931, as amended and re-enacted by Section 8, Chapter 103, Session Laws of Wyoming, 1933, be amended and re-enacted to read as follows:

Section 122-207. Each division superintendent of a water division shall receive a — salary of Fifteen Hundred (\$1500.00) Dollars per annum, payable in monthly installments, — in full compensation for all his services, and shall, in addition thereto, be paid his — actual traveling expenses when called away from home in the performance of his duties. Such superintendents shall not engage in any business which will conflict with their duties as — such superintendents.

Section 2. That Section 109-1214, Wyoming Revised Statutes, 1931, as amended and — re-enacted by Section 14, Chapter 103, Session Laws of Wyoming, 1933, as amended and re-enacted by Section 7, Chapter 149, Session Laws of Wyoming, 1937, be amended and re-enacted to read as follows:

Section 109-1214. The salary of the commissioner of labor shall be Three Thousand—(\$3000.00) Dollars per annum, such compensation to be audited and paid in the same manner—as the salaries of other state officers. The commissioner shall appoint a deputy commis—sioner of labor whose salary shall be Twenty Seven Hundred (\$2700.00) Dollars per annum,—such compensation to be audited and paid monthly as other state salaries are paid. The—deputy labor commissioner shall work under the direction of the commissioner of labor and—statistics who shall be responsible for his official acts. His term of office shall extend during the pleasure of the commissioner of labor and statistics or until his successor is—appointed.

appointments at his pleasure. The said deputy insurance commissioner shall receive a—
salary of Twenty four Hundred (\$2400.00) Dollars per annum, which, together with the pay—
ment of examiners, clerks and other necessary assistants, shall be paid according to the—
accounting laws of the state.

Section 5. That Section 1 of Chapter 93, Session Laws of Wyoming, 1935, be amended and re-enacted to read as follows:

Section 5. The Board, upon organizing, shall appoint a Chief Executive Officer who—shall be graduate of a recognized veterinary college or of the veterinary department of a—recognized university, and who must be licensed to practice veterinary medicine in the State of Wyoming, and who shall be the State Veterinarian whose salary shall not exceed Thirty—nine Hundred (\$3900.00) Dollars a year, and whose term of office shall extend during the—pleasure of the Wyoming Live Stock and Sanitary Board and until his successor is appointed—and qualified.—

Section 7. This Act shall take effect and be in force from and after its passage.
