- 7 in every county of the state because of the assistance
- 8 provided by the Wyoming Arts Council with support from the
- 9 National Endowment for the Arts; and
- 10 WHEREAS, National Endowment for the Arts funding of
- 11 \$601,300.00 in fiscal year 1994 combined with \$296,281.00
- 12 provided by the state helped generate \$12.3 million in

- 16 WHEREAS, direct National Endowment for the Arts fund-
- ing assists some of Wyoming's major arts institutions who
- 18 bring national and international attention to the state
- 19 for their artistic achievements; and
- 20 WHEREAS, National Endowment for the Arts funding in
- 21 Wyoming and in other parts of the nation has enabled arts

- 1 organizations to win matching support from private
- 2 sources; and
- 3 WHEREAS, all great nations support the arts knowing
- 4 the arts are vital to a society's well-being and Congress
- 5 in 1965 noted "An advanced civilization must . . . give
- 6 understanding of the past, a better analysis of the pres-
- 7 ent, and a better view of the future".
- 8 NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE LEG-
- 9 ISLATURE OF THE STATE OF WYOMING:
- 10 Section 1. That the Congress of the United States of
- 11 America is encouraged to reauthorize continuation of the
- 12 National Endowment for the Arts and its sister agencies,
- 13 the National Endowment for the Humanities and the Insti-
- 14 tute for Museum Services, and to provide adequate funding
- 15 to enable them to continue their leadership roles in our
- nation on behalf of our country's culture.

Section 2. That the Secretary of State of Wyoming transmit copies of this resolution to the President of the United States, to the President of the Senate and the Speaker of the House of Representatives of the United States Congress and to the Wyoming Congressional Delegation.
