

6 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF WYOMING,
7 two-thirds of all the members of the two houses, voting
8 separately, concurring therein:

9 Section 1. The following proposal to amend Wyoming
10 Constitution, Article 19 by creating a new Section 12 is
11 proposed for submission to the electors of the State of
12 Wyoming at the next general election for approval or

1 rejection, to become valid as a part of the constitution
2 if ratified by a majority of the electors voting at the
3 election:

4 ARTICLE 19, SECTION 12. LIMITATION ON THE TAKING OF
5 WILDLIFE PROHIBITED; EXCEPTIONS. Except for the protection
6 of wildlife species which are in danger of extinction or
7 which are not considered to be game species, no law shall
8 be passed by the legislature which prohibits the taking
9 and consumptive use of wildlife.

10 Section 2. The Secretary of State shall endorse the
11 following statement on the proposed amendment:

12 The adoption of this amendment will prohibit the
13 Wyoming Legislature from passing laws prohibiting the tak-
14 ing and consumptive use of wildlife, except for protecting
15 endangered species and nongame species.
