1 rejection, to become valid as a part of the constitution 2 if ratified by a majority of the electors voting at the 3 election:

ARTICLE 19, SECTION 12. LIMITATION ON THE TAKING OF WILDLIFE PROHIBITED; EXCEPTIONS. Except for the protection of wildlife species which are in danger of extinction or which are not considered to be game species, no law shall be passed by the legislature which prohibits the taking and consumptive use of wildlife.

Section 2. The Secretary of State shall endorse the following statement on the proposed amendment:

12 The adoption of this amendment will prohibit the 13 Wyoming Legislature from passing laws prohibiting the tak-14 ing and consumptive use of wildlife, except for protecting 15 endangered species and nongame species.
