- 1 A JOINT RESOLUTION proposing an amendment to Article 1,

- 5 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF WYOMING,
- 6 two-thirds of all the members of the two houses, voting
- 5 separately, concurring therein:
- 8 Section 1. The following amendment to Article 1,
- 9 Section 9 of the Wyoming Constitution is proposed for sub-
- 10 mission to the electors of the State of Wyoming at the
- 11 next general election for approval or rejection, to become
- 12 valid as a part of the constitution if ratified by a
- majority of the electors. The amendment is as follows:

1 Article 1, Section 9. Trial by jury inviolate. 2 right of trial by jury shall remain inviolate in criminal cases, but a jury in civil cases in all courts or in crim-3 4 inal cases in-courts-not-of-record, WHERE THE CHARGE IS A 5 MISDEMEANOR may consist of less than twelve men (12) PER-6 SONS, as may be prescribed by law. Hereafter a grand jury 7 may consist of twelve men (12) PERSONS, any nine (9) of whom concurring may find an indictment, but the legis-8 9 lature may change, regulate or abolish the grand jury 10 system.

Section 2. The following statement shall be endorsed on the foregoing proposed amendment by the Secretary of State of Wyoming:

The adoption of this amendment will permit juries of less than twelve (12) persons in trials of persons charged with misdemeanors.
