## A BILL

for

1 AN ACT relating to motor vehicle license plates; authorizing  
2 the display of special children's trust fund license plates  
3 as specified; providing for the production and sale of such  
4 plates; specifying the cost and distribution of proceeds  
5 from the sale of such plates; and providing for an effective

8 *Be It Enacted by the Legislature of the State of Wyoming:*

10 **Section 1.** W.S. 31-2-205 by creating a new subsection  
11 (c) is amended to read:

13 **31-2-205. Display of license plates.**

15 (c) Notwithstanding subsection (a) of this section,  
16 special children's trust fund license plates may be  
17 displayed in lieu of the regular issued license plates. The  
18 special children's trust fund license plates shall bear the

1 same county, numbers and letters on both the front and rear  
2 plates as the regular issued license plates for the vehicle.  
3 The annual dated renewal sticker shall be affixed to the  
4 special children's trust fund license plates in the same  
5 location as would be required on the regular issued license  
6 plates. The department shall, after consultation with the  
7 department of family services advisory council, prescribe  
8 the design of the children's trust fund license plates. The  
9 department shall arrange for the production of the  
10 children's trust fund license plates which shall be  
11 available for purchase upon application to the county  
12 treasurer. A special application shall be issued by the  
13 department upon payment of an application fee of thirty  
14 dollars (\$30.00) in addition to the registration fees  
15 required under W.S. 31-3-101. The special application fee  
16 under this subsection shall be used to cover the costs of  
17 the special children's trust fund license plates and any  
18 administrative expenses associated with application for the  
19 plates. Any excess revenues under this subsection shall be  
20 deposited in the state treasury and credited to the  
21 children's trust fund created by W.S. 14-8-106.

1       **Section 2.**   This act is effective immediately upon  
2 completion of all acts necessary for a bill to become law as  
3 provided by Article 4, Section 8 of the Wyoming  
4 Constitution.

## Source of revenue:

The additional revenues are derived from the \$30 special application fee.

## Assumptions:

The increase in revenue is an optimistic estimate of the sale of special children's trust fund license plates. The highway fund would be reimbursed the estimated costs of supplying each county with enough plates for 100 cars and 100 trucks as a beginning. This would result in an additional \$138,000 of revenue if they are all sold. The revenues generated are equally divided over the next three fiscal years. In short, the demand for these plates is difficult, if not impossible, to forecast.

## Source of expenditure:

The expenditure is a result of supplying 23 counties with enough license plates for 100 cars and 100 trucks.

## Assumptions:

At a projected costs of \$2.00 per license plate for a single scotchlite material design using the same number of different colors and complexity as the present Purple Heart the initial outlay is anticipated to be approximately \$24,000.
