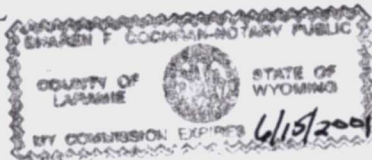

**Instructions for filling out  
"Application for Registration of Trademark or Service Mark"**

Forms must be submitted in duplicate. One copy will be returned to you showing the file date and file number. Send three facsimiles or specimens of the trademark or service mark as it is actually used. Photocopies or drawings are not acceptable. The filing fee is \$100.00. Checks must be made payable to the Secretary of State.

The sworn application must be executed by the individual applicant or a member, manager, trustee, partner, officer or director of the applicant. Registration is effective for a term of five years and is renewable for like term upon application filed within six months prior to expiration of such term. Renewal forms are mailed by the office of the Secretary of State to registrants whose trademark or service mark is up for renewal.

Copies of the Wyoming Trademark statutes are available via the internet at <http://soswy.state.wy.us>. A trademark or service mark may be canceled at any time upon written request to the Secretary of State and payment of a \$10.00 filing fee. Assignment forms are available on the internet or from the office of the Secretary of State upon request. The filing fee to assign a trademark or service mark is \$25.00.

The following general classes of goods and services are established for convenience of administration of this Act, but not to limit or extend the applicant's or registrant's rights. A single application for registration of a mark may include any and all goods upon which, or service with which, the mark is actually being used in a single class.
