Our office has received a few calls about the April 1 deadline for completing USPAP. The Certified Real Estate Appraiser Board does intend to remove this requirement from administrative rules. However, this rule is still active and applies to all Certified Appraisers in Wyoming. There is no guarantee that this rule will be removed from rules by April 1, 2018, and per the law, the Board must to enforce rules as adopted not rules pending adoption. Amending rules can take six months or longer, and, the upcoming budget session of the Wyoming Legislature can cause delays in new/amended rule implementation.


