6 Be It Enacted by the Legislature of the State of Wyoming:

7 Section 1. There is appropriated from the general  
 8 fund of the State of Wyoming to the Legislative Service  
 9 Office the sum of three million seven hundred fifty-six  
 10 thousand nine hundred fifty-five dollars (\$3,756,955.00)


