A BILL for AN ACT amending and re-enacting Subsections (A) and (D) of Section 42-15, Wyoming Statutes 1957, as amended by Section 2, Chapter 90, Session Laws of Wyoming 1965, relating to relief grants, providing for the allocation of grants and broadening the class of recipients for whom department may appoint custodians; amending and re-enacting Section 42-28, Wyoming Statutes 1957, as amended by Section 6, Chapter 90, Session Laws of Wyoming 1965, relating to eligibility for aid to dependent children, granting additional powers and duties to the state department of welfare; and amending and re-enacting Section 42-32, Wyoming Statutes 1957, as amended by Section 1, Chapter 184, Session Laws of Wyoming 1961, relating to aid to the blind, striking an exception.
