1	Section 1. W.S. 31-5-233(d), (e) and (h) and by

(j) A PERSON CONVICTED OF VIOLATING THIS SECTION AND 4 5 PUNISHABLE UNDER SUBSECTION (d) OF THIS SECTION SHALL BE 6 IMPRISONED FOR NOT LESS THAN FOUR (4) DAYS AND FINED NOT 7 LESS THAN FIVE HUNDRED DOLLARS (\$500.00) AND FOR A SUBSE-8 QUENT CONVICTION IMPRISONED FOR NOT LESS THAN FOURTEEN 9 (14) DAYS AND FINED NOT LESS THAN SEVEN HUNDRED DOLLARS 10 (\$700.00) IF THE PERSON COMMITS ACTS CONSTITUTING RESIST-ING ARREST OR ASSAULTING A PEACE OFFICER DURING THE COURSE 11 12 OF THE ARREST OF THE PERSON FOR VIOLATING THIS SECTION.
