BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:-

Section 1. A certified copy of any paper or record under the hand and seal of the officer who, by the laws of this state, has the legal custody of such paper or record shall be competent evidence in any court to prove, and shall be prima facie evidence of, the contents of such paper or record.

Section 2. All acts or parts of acts in conflict with this act are hereby repealed.

Section 3. This act shall be in force from and after July 1st, 1923.
