6 Be It Enacted by the Legislature of the State of Wyoming:

7 Section 1. W.S. 27-12-102(a) by creating a new para-  
8 graph (xxi) is amended to read:

9 27-12-102. Definitions.

1 (a) As used in this act:

2            (xxi) "CULPABLY NEGLIGENT" MEANS A GREAT OR EXCES-  
3        SIVE DEVIATION FROM THAT STANDARD OF CARE WHICH A REASON-  
4        ABLE, PRUDENT PERSON WOULD EXERCISE UNDER THE SAME OR  
5        SIMILAR CIRCUMSTANCES TO AVOID A SUBSTANTIAL AND  
6        UNJUSTIFIABLE RISK OF HARM.

7           Section 2. This act is effective May 27, 1983.
