1 AN ACT relating to salary and benefit adjustments; provid-  
2 ing an appropriation as specified for salary and benefit  
3 adjustments for government employees as specified; and  
4 providing for an effective date.

5 Be It Enacted by the Legislature of the State of Wyoming:

6 Section 1.

7 (a) The following amounts are appropriated from the  
8 general fund to the state auditor to be expended as autho-  
9 rized by the governor for the fiscal year commencing July  
10 1, 1993:

1           (i) Five million five hundred thousand dollars  
2   (\$5,500,000.00) for salary adjustments for employees of  
3   the University of Wyoming;

4           (ii) Three million three hundred thousand dol-  
5   lars (\$3,300,000.00) for salary adjustments for employees  
6   of Wyoming community colleges;

7           (iii) Nine million one hundred thousand dollars  
8   (\$9,100,000.00) for salary adjustments for employees of  
9   the executive branch of state government;

10          (iv) Three hundred thousand dollars  
11   (\$300,000.00) for salary adjustments for employees of the  
12   judicial branch of state government;

13          (v) Two million five hundred thousand dollars  
14   (\$2,500,000.00) to increase the state's contribution to  
15   the state health plan under W.S. 9-3-210 by an additional  
16   twenty dollars (\$20.00) per month for each state executive  
17   and judicial branch employee.

18          (b) Executive and judicial branch employees whose  
19   salaries and benefits are paid from nongeneral fund  
20   sources shall receive the same salary and benefit  
21   increases as provided in subsection (a) of this section

1 and the necessary amounts are appropriated from the fund  
2 and accounts from which such salaries and benefits are  
3 funded.

4 Section 2. This act is effective July 1, 1993.
