10 (a) Any state, county or precinct officer or employee
11 required to travel in the performance of the duties of his
12 office is entitled to receive reimbursement for all actual
13 and necessary transportation expenses incurred as provided
14 by one (1) of the following methods:

15 (i) If common carrier transportation is used,
16 the actual expense not to exceed economy fare charged the
17 general public is reimbursable. If deluxe accommodations
18 are desired, the amount exceeding economy fare shall be
19 paid personally by the officer or employee. Passenger cou-
20 pons issued by the transportation company or an official
21 fare receipt shall accompany the claim submitted to the
22 state auditor or the board of county commissioners for

1 audit and payment. With prior approval of the ~~governor~~
2 RESPECTIVE EXECUTIVE AGENCY HEAD, the management council
3 or the chief justice of the supreme court, actual expenses
4 in excess of the economy fare may be reimbursed;

5 Section 2. This act is effective immediately upon
6 completion of all acts necessary for a bill to become law
7 as provided by Article 4, Section 8 of the Wyoming Consti-
8 tution.


