

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

9 Section 1. Sections 7-338.1 and 7-338.2 of the stat-  
10 utes are created to read:

11 ARTICLE 4.1

12 VOLUNTEER PROBATION AND PAROLE COUNSELING PROGRAM

13 7-338.1. Volunteers may assist state probation and  
14 parole officer and field supervisors; reimbursement for  
15 expenses.

16 (a) In order to further the objectives of sections

1     7-324 through 7-337, of the statutes, the state probation  
2     and parole officer is authorized to select, organize and  
3     train local volunteer citizens of good moral character,  
4     who, acting under his supervision, may:

5             (i)     Advise and assist field supervisors of  
6                     probationers and parolees with special  
7                     reference to vocational and technical  
8                     education;

9             (ii)    Maintain liaison with all appropriate  
10                    municipal, county, state and federal  
11                    agencies whose services aid in the  
12                    reintegration of offenders into society;

13            (iii)   Assist in programs relating to the  
14                    social, moral and psychological needs of  
15                    persons released under probation and  
16                    parole supervision;

17            (iv)    Not receive compensation from the state  
18                    treasury. However, at the discretion of  
19                    the state probation and parole officer,  
20                    volunteers may be reimbursed for neces-  
21                    sary and actual expenses incurred in  
22                    performing the duties described herein.

23            7-338.2. Volunteers do not have power of arrest,  
24     etc. Volunteers do not have the same powers of arrest and  
25     right to executive process as the state probation and
