- Be It Enacted by the Legislature of the State of Wyoming: 11

1 Section 1. W.S. 34-1-142 through 34-1-144 are cre-2 ated to read:

3 34-1-142. Statement of consideration paid for real 4 property required; authority of state board of control. Every grantee who has a deed to real estate recorded, 5 6 which deed was executed after June 15, 1984, shall at the time such deed is presented for recording file with the 7 register of deeds a completed statement as prescribed by 8 9 the state board of equalization. This statement may require the recitation of any information contained in the 10 deed, the total consideration paid, the amount of the 11 total consideration attributable to factors other than the 12 13 purchase of the real estate itself, and other factors which may influence the transaction. This statement shall 14 15 be signed, verified under oath and filed by the grantee or his authorized agent. If the grantee fails to furnish 16 such statement the register of deeds shall not record the 17 The register of deeds shall indicate on the state-18 deed. ment the book and page on which the deed is recorded, and 19 immediately forward the statement to the county 20 The county assessor shall process the statement 21 according to the instructions of the state board of equal-22 23 ization and shall, when directed, forward the statement to

- 1 the state board of equalization. This statement and the
- 2 information contained therein shall be confidential and
- 3 available to tax officials and auditors of state and
- 4 county government.
- 5 34-1-143. Filing fee. The county clerk shall collect
- 6 a fee of four dollars (\$4.00) for the first page and two
- 7 dollars (\$2.00) for each additional page for recording the
- 8 disclosure statement required by W.S. 34-1-142.
- 9 34-1-144. Penalty for filing false statement. Any
- 10 person who knowingly files a false statement as required
- 11 by W.S. 34-1-142 is subject to the penalties provided by
