BE IT ENACTED BY THE * * * LEGISLATURE OF THE STATE OF WYOMING:

Section 1. The Revenue Department is hereby authorized to expend from its income, the amount of One Million Five Hundred Seventy-three Thousand Four Hundred Eighty-four Dollars (\$1,573,484) for its general operating purposes and One Hundred Thousand Dollars (\$100,000) for capital outlay during the biennium ending June 30, 1965.

Section 2. The Department of Revenue of the State Board of Equalization is hereby authorized to expend such sums or so much thereof as shall be necessary for administrative expenses and capital outlay until June 30, 1965, in addition to the amount authorized in the General Fund Appropriation of the Department of Revenue of the State Board of Equalization.
