1 35-9-701. Volunteer fire services immune from lia-
2 bility; exceptions. No member of any organization provid-
3 ing volunteer fire services and not covered under W.S.
4 1-39-101 through 1-39-120 is liable for property damages
5 resulting from fire service acts or omissions in good
6 faith, except this immunity does not apply to acts or
7 omissions constituting gross negligence or willful and
8 wanton misconduct.

9 Section 2. This act is effective May 22, 1987.
