CHAPTER 254

GAME AND FISH LICENSE FEES-2

Original House Bill No. 197

AN ACT to amend W.S. 23-1-102(a)(ix), 23-2-101(b) and (d), 23-2-102(c), 23-2-107(b), 23-2-201(b)(i) through (iii) and (viii) through (xii), 23-2-301(a) and 23-3-105; and to repeal W.S. 23-2-301(a)(i) through (iv) relating to game and fish licenses; providing that spouses of active military members who are residents of state shall also be considered residents for hunting and fishing licenses; modifying license fees as specified; providing for landowner coupons for elk; modifying game bird age restrictions and license requirements; increasing landowner payment as specified; eliminating archaic fees; and providing for effective dates.

Be It Enacted by the Legislature of the State of Wyoming:

Section 1. W.S. 23-1-102(a)(ix), 23-2-101(b) and (d), 23-2-102(c), 23-2-107(b), 23-2-201(b)(i) through (iii) and (viii) through (xii), 23-2-301(a) and 23-3-105 are amended to read:

23-1-102. General definitions.

(a) As used in this act:

(ix) "Resident" means a United States citizen who has been a resident of Wyoming and domiciled in Wyoming for not less than one (1) year and who has not claimed residency elsewhere for any purpose during that one (1) year period immediately preceding the date of application for a license, permit or certificate. Having a Wyoming mailing address shall not alone prove Wyoming residency. "Resident" also includes any alien who has resided continuously in Wyoming for at least one (1) year immediately prior to the date of making application for a game and fish license. "Resident" also includes the spouse of any active duty member of the armed forces of the United States who qualifies as a resident under this paragraph;

23-2-101. Fees; restrictions; nonresident application fee; nonresident licenses; verification of residency required.

(d) The commission may issue deer or antelope licenses in areas in which all licenses initially authorized were not purchased or in which additional harvest is desired, allowing a licensee to take a deer or antelope of such sex or age as designated by the commission. The fee for the license may be reduced by the commission to the level necessary to achieve the desired management objectives, but in no case shall a resident or nonresident license fee be less than the landowner's coupon fee.

23-2-102. Age restrictions; game animals; game birds.

(c) No person fourteen (14) years of age or older shall take any game bird without obtaining the proper license. A person under fourteen (14) years of age may take any game bird in this state without a license if accompanied by an adult.

23-2-107. Wild bison licenses.

(b) A resident applicant shall pay a license fee of two hundred twenty dollars (\$220.00). A nonresident applicant shall pay a license fee of one thousand three hundred fifty dollars (\$1,350.00) and shall pay the fee required by W.S. 23-2-101(e).

23-2-201. Fees; restrictions; verification of residency required.

23-3-105. Antelope, deer and elk coupons; payment to landowner; kill on federal or state land.

- (a) Antelope, deer and elk licenses shall have two (2) coupons attached, each bearing the same serial number as the body of the permit, one (1) designated "antelope, deer or elk coupon" and one (1) designated "landowner's coupon".
- (b) The landowner's coupon shall promptly be detached, dated, signed and delivered to the landowner. The landowner on or before February 1 following the year for which the license was valid, shall deliver to the department the coupon and an affidavit that the antelope, deer or elk for which the coupon was delivered was killed on his land. Upon receipt of the coupon and affidavit the department shall pay the landowner nine dol-

lars (\$9.00) for each coupon from an antelope, deer or elk license. Landowner's coupons are not transferable. Any unauthorized person attempting to collect any sum for any landowner's coupon is guilty of a second degree misdemeanor.

(c) When an antelope, deer or elk is shown to have been killed on federal or state land, the licensee shall detach, date, and sign the landowner's coupon and mail or otherwise deliver the coupon to the Cheyenne office of the department.

Section 2. W.S. 23-2-301(a)(i) through (iv) is repealed.

Section 3.

- (a) Except as provided by subsection (b) of this section, this act is effective January 1, 1992.
- (b) Notwithstanding subsection (a) of this section, W.S. 23-1-102(a)(ix) as amended by section 1 of this act is effective July 1, 1991.

Became law without governor's signature March 10, 1991.
