

CHAPTER 7

YOUTH TREATMENT CENTER-REPEAL

Original House Bill No. 12

AN ACT relating to Wyoming youth treatment center; repealing statutory references to the Wyoming youth treatment center and conforming related provisions; and providing for an effective date.

Be It Enacted by the Legislature of the State of Wyoming:

Section 1. W.S. 1-22-109(a)(vi), 5-6-112(b)(i), 6-5-208, 7-1-107(b)(i), 9-2-2104(a)(viii), 14-6-201(a)(xxiv), 14-6-301(a)(iii) and 23-2-207(a)(ii) are amended to read:

1-22-109. Consent to adoption.

(a) A written relinquishment of custody of the child to be adopted and written consent to adoption shall be filed with the petition to adopt and shall be signed by:

(vi) The executive head of the agency to whom the child has been relinquished for adoption; ~~or the department of family services if the child has been committed to the Wyoming youth treatment center and has been maintained by or in the center for a period of one (1) year prior to the filing of the petition for adoption; or~~

5-6-112. Detention of juvenile offenders.

(b) As used in W.S. 5-6-112 and 5-6-113:

(i) "Juvenile detention facility" means any facility which may legally and physically restrict and house a child, other than the Wyoming boys' school, the Wyoming girls' school, ~~the Wyoming youth treatment center,~~ the Wyoming state hospital or other private or public psychiatric facility within the state of Wyoming. A juvenile detention facility may be housed within an adult jail or correction facility if the facility otherwise meets the requirements of state law;

6-5-208. Taking controlled substances or liquor into jails, penal institutions or mental hospitals; penalties.

Except as authorized by a person in charge, a person commits a felony punishable by imprisonment for not more than three (3) years, a fine of not more than three thousand dollars (\$3,000.00), or both, if that person takes or passes any controlled substance or intoxicating liquor into a jail, a state penal institution, the Wyoming boys' school, Wyoming girls' school, ~~Wyoming youth treatment center,~~ a correctional facility operated by a private entity pursuant to W.S. 7-22-102 or the state hospital.

7-1-107. Detention of juvenile offenders.

(b) As used in W.S. 7-1-107 and 7-1-108:

(i) "Juvenile detention facility" means any facility which may legally and physically restrict and house a child, other than the Wyoming boys' school, the Wyoming girls' school, ~~the Wyoming youth treatment center,~~ the Wyoming state hospital or other private or public psychiatric facility within the state of Wyoming. A juvenile detention facility may be housed within an adult jail or correction facility if the facility otherwise meets the requirements of state law;

9-2-2104. Duties and powers of director of department.

(a) The director shall:

(viii) Appoint and prescribe the duties of the superintendent of the Wyoming boys' school, and the superintendent of the Wyoming girls' school, ~~and the superintendent of the Wyoming youth treatment center.~~ Each superintendent shall be under the direct authority and control of the director and may be removed by the director at any time without cause.

14-6-201. Definitions; short title; statement of purpose and interpretation.

(a) As used in this act:

(xxiv) "Juvenile detention facility" means any facility which may legally and physically restrict and house a child, other than the Wyoming boys' school, the Wyoming girls' school, ~~the Wyoming youth treatment center,~~ the Wyoming state hospital or other private or public psychiatric facility within the state of Wyoming. A juvenile detention facility may be housed within an adult jail or correction facility if the facility otherwise meets the requirements of state law;

14-6-301. Definitions.

(a) As used in W.S. 14-6-301 through 14-6-308:

(iii) "Institution" means the Wyoming boys' school, Wyoming girls' school, ~~Wyoming youth treatment center~~ and any other state institution, including a youth correctional facility operated by a private entity in which a Wyoming youth is placed pursuant to W.S. 14-6-201 through 14-6-243;

23-2-207. Special limited fishing permit for hospitalized veterans, residents of state institutions and court placed children.

(a) Upon an appropriate form furnished by the commission, a special limited fishing permit may be issued without charge by:

(ii) The department of health or the department of family services to any resident in the veterans' home of Wyoming, ~~Wyoming youth treatment center,~~ Wyoming state hospital, Wyoming state training school, Wyoming boys' school and the Wyoming girls' school, which entitles the institutionalized resident to fish while under the direct control of the appropriate institution;

Section 2. W.S. 9-2-2006(c)(ii)(A), 25-1-201(a)(v) and 25-7-101 are repealed.

Section 3. This act is effective July 1, 1998.
