- 10 (a) The state shall contribute an amount necessary to

- 1 pay one-hundred-ten-dollars--(\$110.00) THE FOLLOWING
- 2 AMOUNTS per month for each employee and official enrolled
- 3 in the plan in accordance with subsections (b) and (c) of
- 4 this section:
- 5 (i) ONE HUNDRED FORTY DOLLARS (\$140.00) IF THE
- 6 TOTAL INCOME OF THE EMPLOYEE OR OFFICIAL PAID FROM STATE
- 7 FUNDS IS TWENTY THOUSAND DOLLARS (\$20,000.00) OR LESS; OR

- 9 TOTAL INCOME OF THE EMPLOYEE OR OFFICIAL PAID FROM STATE

- including the University of Wyoming and the community col-
- 13 leges in the state, shall pay to the board one-hundred-ten
