8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

9 Section 1. Any person over the age of eighteen (18)
10 years is hereby determined to be an adult for all purposes
11 and all of the disabilities of minority are hereby extinguished;
12 said person is hereby determined, for all legal purposes, to be
13 of full age.

14 Section 2. Sections 14-1, 14-2 and 14-3, Wyoming Statutes
15 1957, Compiled 1965, are hereby repealed.

16 Section 4. This act shall take effect on January 1, 1970.
