

5 Be It Enacted by the Legislature of the State of Wyoming:

6 Section 1. W.S. 7-6-103(b) is amended to read:

7 7-6-103. Creation of office of state public defender;
 8 appointment of state public defender and assistants;
 9 duties; removal.

10 (b) The state public defender shall be appointed by
 11 ~~and-shall-serve-at-the-pleasure-of~~ the governor WITH THE

1 ADVICE AND CONSENT OF THE SENATE IN ACCORDANCE WITH W.S.
2 28-12-101 THROUGH 28-12-103. THE STATE PUBLIC DEFENDER
3 SHALL BE APPOINTED TO A TERM OF SIX (6) YEARS AND MAY BE
4 REMOVED BY THE GOVERNOR AS PROVIDED IN W.S. 9-1-202.

5 Section 2. In accordance with W.S. 28-12-101(b), upon
6 the effective date of this act the governor shall make a
7 temporary appointment to the office of state public
8 defender which appointment shall be effective until March
9 1, 1995.

10 Section 3. This act is effective July 1, 1994.
