AN ACT to amend and re-enact Section 37-910, Wyoming Compiled Statutes, 1945, as amended by Section 1, Chapter 94, Session Laws of Wyoming, 1947, relating to compensation of members of State Board of Cosmetology.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

That Section 37-910, Wyoming Compiled Statutes, 1945, as amended by Section 1, Chapter 94, Session Laws of Wyoming, 1947, be amended and re-enacted as follows:

Section 1. Each member of said State Board shall receive \* \* \* TEN DOLLARS (\$10.00) per day when actually engaged in performing the duties of conducting examination of applicants as provided in Section 37-909, Wyoming Compiled Statutes, 1945, and the sum of \* \* \* TEN DOLLARS (\$10.00) per day in the performance of the duties of the enforcement of this Act, and for services as examiners appointed by the Board as herein provided.

The Secretary-Treasurer shall receive such salary as the State Board shall from time to time approve.

That Section 37-910, Wyoming Compiled Statutes, 1945, as amended by

re-enacted as follows:

Section 1. Each member of said State Board shall receive \* \* \*
