5 Be It Enacted by the Legislature of the State of Wyoming:

6 Section 1. W.S. 1-1-117 is created to read:

7 1-1-117. Punitive damages in personal injury  
 8 actions. In any action to recover damages for negligence  
 9 resulting in death or personal injury, no award of puni-  
 10 tive damages shall be made unless the trier of fact finds

**NO SIGNIFICANT FISCAL IMPACT**

1     beyond a reasonable doubt that the defendant acted in a
