8 Be It Enacted by the Legislature of the State of Wyoming:

9 Section 1. W.S. 9-102.1 is created to read:

10 9-102.1. County memorial hospitals and hospital dis-
11 tricts; certified audits in lieu of examination by state
12 examiner. When an annual audit has been performed and an
13 audit report rendered by an independent certified public
14 accountant on a county memorial hospital or a hospital
15 district, the state examiner may accept such audit and
16 audit report in lieu of a state examiner's annual exami-

1 nation of the books and accounts of such county memorial
2 hospital or hospital district.

3 Section 2. This act is effective immediately upon
4 passage.
