Exhibit A – Description of the Trademark

The mark is the logo for the restaurant.

It is a square with a background color of "Sunflower Yellow Pantone 1235". Inside the square are the letters "WHW" in all caps. Those letters are in "Yikes! True Type Font." The "WHW" letters are the color "Tomato Red-Pantone: 485." They generally cover the center of the square up to almost the top of the square. The letters "WHW" are outlined with white, and then black outside of the white.

Below the letters "WHW" are the words "Wyoming Hot Wings" in a smaller font size, but the same typeface as the "WHW." The words "Wyoming Hot Wings" are the color white. They are covered in background by a black oval that on both the right and left sides extends into rectangles that form into 45 degree angles just outside the "W" in "Wyoming" and the "T" in "Hot." The words "Wyoming Hot Wings" are set such that the words "Wyoming Hot" are directly on top of and centered over the word "Wings."
