A BILL

1 AN ACT to amend W.S. 9-4-602 relating to federal mineral  
 2 royalties; providing for quarterly distribution of such  
 3 royalties under certain conditions; and providing for an  
 4 effective date.

5 Be It Enacted by the Legislature of the State of Wyoming:

6 Section 1. W.S. 9-4-602 is amended to read:

7 9-4-602. Same; state treasurer's duty. EXCEPT AS  
 8 HEREAFTER PROVIDED, distribution under W.S. 9-4-601 shall  
 9 be made by the state treasurer within thirty (30) days  
 10 after the receipt of the government royalty funds for the

1 preceding period. IF THE STATE BEGINS RECEIVING ITS SHARE  
2 OF FEDERAL MINERAL ROYALTIES ON A CONTINUING MONTHLY  
3 BASIS, DISTRIBUTION UNDER W.S. 9-4-601 SHALL BE MADE BY  
4 THE STATE TREASURER WITHIN THE FIRST TEN (10) DAYS OF  
5 JANUARY, APRIL, JULY AND OCTOBER IN EACH YEAR AND THE  
6 QUARTERLY PAYMENTS SHALL COMMENCE IN THE QUARTER FOLLOWING  
7 THE FIRST MONTH IN WHICH THE FEDERAL MINERAL ROYALTIES ARE  
8 RECEIVED BY THE STATE ON A CONTINUING MONTHLY BASIS.

9 Section 2. This act is effective May 27, 1983.


