The ACT online window closing April 12th.

### ACT WORKKEYS



All 11th and 12th grade students have the opportunity to take the ACT WorkKeys assessment.

After successfully completing Applied Math, Graphic Literacy, and Workplace Documents portions of the WorkKeys assessment, students will earn the ACT [NCRC](#) certificate.

This spring, Wyoming schools will have an opportunity to administer the ACT WorkKeys Assessment in the following window:

## WY-ALT INDEPENDENT FIELD TEST

The WY-ALT Independent Field Test window is April 9- April 27.



WY-ALT students will be participating in an online independent field test during the window April 9-27. There will be 10 items per subject. The online assessment is adaptive and eliminates the use of the Student Placement Questionnaire and the Scale Score Starting Points Table. The IFT is administered through TDS and requires two devices that can connect to the internet (i.e., computers, tablets). One device will be used to access the Test Administrator Interface, accessible through the [Wyoming Assessment Portal](#). The other device will be used to access the Student Interface through the Secure Browser. **The Technology Coordinator is responsible for downloading and installing the Secure Browser on all devices used to access the Student Interface.** Please review the [Secure Browser Installation Manual](#) for more information.
